Volunteer Application, Agreement and Release

Thank you so much for your interest in volunteering with Frisky Business Palm Springs Cat Café. Everything we do starts and ends with our cats' welfare. Volunteers are an integral part of ensuring that meeting their needs will always come first. Please read through the following Agreement and Release, sign and date where indicated, and return to Claire Rogers, Owner.

1. Volunteer Acknowledgement and Participation. I acknowledge that I have voluntarily agreed to serve as a volunteer for Anywhere With You LLC d/b/a Frisky Business Palm Springs Cat Café ("Frisky Business"), a California Limited Liability Company, whose mission is to offer various services, merchandise, and events in a fun, unique, relaxed environment for both cats and people alike, and which facilitates the adoption of happy, healthy cats to cat lovers who wish to adopt them.
2. Nature and Scope of Services. As a volunteer I will be contributing my time and effort to various services for Frisky Business. The services will be performed by me as assigned by a company owner. In the course of performing the services, I agree:
 - I will abide by Frisky Business's mission, rules, regulations, policies and procedures while I am a volunteer;
 - I will not engage in any unsafe, illegal or unethical activities while acting as a volunteer;
 - Since I will be interacting with cats and may be lifting, carrying, moving or otherwise engaging in limited physical labor, I will be respectful of my own limitations and will inform Frisky Business immediately of such limitations;
 - I will treat all Frisky Business officers, directors, employees, volunteers, cats and members of the public with whom I interact with kindness and respect. I acknowledge that I am volunteering for the best interests of the cats and not for any personal gain or to further any personal agenda;
 - That Frisky Business has the right to revoke volunteer privileges at any time and for any reason.

I further agree as follows:

- That all cats and kittens are the property of The Palm Springs Animal Shelter and shall not be sold, given away, or adopted out without prior approval of authorized personnel.
- To fulfill my duties promptly, professionally, and reliably.
- To arrive promptly for scheduled volunteer assignment and to provide advance notice if I will be late or absent.
- To ask questions if I am unsure of how to do something.
- To accept the guidance, evaluation and decisions of the Frisky Business owner and to treat Frisky Business employees and other volunteers with respect at all times.



- To report any conditions which I feel are unsafe, such as slipping and tripping hazards, inadequate lighting, etc.
 - To report any injury that occurs during volunteer service.
 - To keep an accurate record of all my volunteer hours worked in the volunteer log.
 - To provide the owner with any change of my personal information, such as name, address or phone.
3. No Compensation. I agree to provide my services without pay or compensation of any kind. I further agree that I am not, nor will I become, an employee, agent, contractor or principal of Frisky Business upon execution of this agreement.
 4. No Workers' Compensation Insurance Coverage. I acknowledge and understand that as a volunteer of Frisky Business I am not covered by Frisky Business' Workers' Compensation or any other insurance policy for any damages or injuries I may sustain during my volunteer activities.
 5. Responsibility for My Own Acts and Omissions. I hereby agree to be legally and financially responsible and will indemnify and hold Frisky Business harmless for my own acts and omissions relating to the service I am voluntarily providing to Frisky Business. I acknowledge that I am responsible for providing my own medical, liability and auto insurance during the performance of my volunteer duties and tasks.
 6. Assumption of Risk. I am voluntarily participating in the activities of Frisky Business with full knowledge of the risks and dangers involved and hereby agree to accept all risks of injury, death or damage to myself and/or my personal property. I understand that animal behavior is unpredictable, and some animals are capable of causing serious injury or death. As a volunteer, I acknowledge that I will come into contact and interact with cats and kittens, and that such work entails risk of personal injury. These risks include, but are not limited to, the risks of being bitten, scratched, injured or frightened by cats or kittens.
 7. Photo, Video and Audio Release. I understand that as a volunteer of Frisky Business, I may be recorded on film, video or other electronic recording media. I hereby consent to such recording and the use by Frisky Business of any recorded images or other media recordings of my name and likeness (the "Recordings") for any purpose related to furtherance of the objectives of Frisky Business. In particular, I grant Frisky Business permission to copyright and use, reuse, publish and republish the Recordings, for marketing, advertising, or any other purpose.
 8. Indemnification. As consideration for being permitted by Frisky Business to participate in activities and provide volunteer services, on behalf of myself, my heirs, personal representatives, and executors, I hereby release, defend, indemnify and hold harmless Frisky Business, and its officers, directors, employees, agents, and volunteers (the "Released Parties"), from any and all suits, claims, causes of action, or demands of any
